These guidelines apply to competitors in the age category Active Cadet to Active Master.

### **GUIDELINE FOR:**

#### **Carnival Nomination Fees**

- Club will pay carnival nomination fees but if you do not attend the carnival the nomination fee is to be refunded to the Club.
- If you attend 3 or more carnivals during the season you are required to be on the Friday night raffle roster or for those members Under 18 years of age must attend to Youth Fundraising events throughout the season or alternatively pay half of the carnival nomination fees.

#### State & National Championship Subsidy

- Member must do a <u>MINIMUM</u> of <u>40 hours beach Patrol</u> at Marcoola Beach
- Maximum subsidy not to exceed 50% of the cost.

Management Committee will decide eligibility for subsidy upon application using the following as a guideline:-

- Raffle roster attendance (for members under 18 years of age that elect to sell raffle tickets must be supervised by a parent or guardian)
  - For members under 18 years of age that do not wish to nominate for the Friday night raffle roster must attend at least two Youth Fundraising Events throughout the season.
- Door knock attendance (provided the Club is participating in that given year)
- Assistance at carnivals
- Attending outside Club events
- Competition at carnivals
- For State Championships: Attendance at Branch Champs.
- For National Championships: Attendance at State Champs.

#### **CRITERIA FOR COMPETITION SUBSIDY**

In order to gain a competition subsidy through the Marcoola SLSC, the applicant must meet the following criteria:

1. Member must be proficient active or award member and has been for a period of at least 12 months.

2. Member must have completed a *minimum* of 40 hours patrol per season (which is calculated from 1<sup>st</sup> January to the 31<sup>st</sup> December)
